The number of quality of life calls has fallen this month and there were no calls of real significance.

Only one street has more than one incident. Three of the four drug incidents refer simply to information received, whilst the fourth relates to a positive stop/search conducted by my Officers.

The public nuisance calls were at different areas on Holburn Street, and were unrelated.

## NOT PROTECTIVELY MARKED

An overall fall in the relevant offences again this month, but there are instances of acquisitive crime occurring.

In particular garages mainly in lanes at the rear of properties are being targeted and there are still thefts occurring from within unsecured vehicles.

We had a number of successes in disrupting and detecting some of these garage break ins and two males have reported for offences occurring in January.

Regardless the best defences are still a good lock (if used), and vigilant neighbours. If someone is hanging around your street and it doesn't feel right - trust your instincts and let us know.

### Streets with more than one crime are as follows:

The North Deeside Road offences came from a stop and search.

The two Rubislaw Square offences occurred on the same night and are related and were insecure vehicles.

### Summary of Calls and Crimefiles compared to last month:

#### AS3A – Ferryhill

- Quality of life calls have reduced by 3
- There were 2 Housebreakings
- Vandalisms have decreased by 2
- There were 2 Thefts from vehicles
- Overall CrimeFile offences have decreased by 4

#### AS3B – Mannofield

- Quality of life calls have increased by 2
- There were 2 Housebreaking
- Vandalisms have increased by 3
- There were 2 Thefts from vehicles
- Overall CrimeFile offences have decreased by 2

#### AS3C – West End

- Quality of life calls have decreased by 1
- There were 4 Housebreakings
- Vandalisms have decreased by 1
- There were 2 Thefts from vehicles
- Overall CrimeFile offences have increased by 3

## **GENERAL INFORMATION**

Though still fairly low levels, once again this month there have been occurrences of Housebreakings and attempted Housebreakings to garages and we would encourage members of the public to be vigilant in their areas.

The offences are often occurring in lanes at the back of properties, and my advice is to fit a cheap but noisy contact alarm to you garage, and always make sure it is locked.

If you see anyone loitering in these lanes, remember descriptions and consider letting us know at the time on 101.

Trust your instincts with this - Who better to assess what is normal in an area than those that live there.

The primary purpose of these e-mail addresses is for residents to report non-criminal queries, such as passing attentions, information, advice and non-criminal quality of life issues, such as youth annoyance. These e-mail addresses are not for reporting crimes or offences. The process for reporting any crimes or offences is to call 101 (Aberdeen Service Centre) who will log the call on our Command and Control system and allocate the incident to our area. Using this process negates the possibility of the report being missed and also ensures that the callers detail, addresses and telephone numbers are noted for our awareness and response.

Your comments and concerns are important to the staff of the West End CPT. This allows us to allocate our resources to the areas causing you the most concern.
