**Summary**

There were two reports of Theft by Housebreaking over the reporting period. These enquiries are on-going. People are again asked to make sure doors are locked and keys stored securely.

There was an increase in section 57 offences which relate to persons being seen in suspicious circumstances. The rise is attributable to one male who was caught and dealt with accordingly by Police.

There were five incidents involving drugs in the Ferryhill area. These relate to four separate incidents. One person was dealt with for being concerned in the supply of controlled drugs and a further person dealt with for possession.

There were thirteen anti-social behaviour calls in the Ferryhill area. These refer to youth annoyance and persons under the influence of alcohol causing issues.

There were six vandalisms in the Ferryhill area; three refer to mindless damage to parked vehicles. Enquiries are on-going. I would urge people to contact Police at the time they see or hear anything of an anti-social nature to allow Police to attend and deal.

There was an increase in road traffic collisions however there have been no significant road traffic accidents in the area over the month of August 2017.

Over the reporting period Police have reported individuals for a number of crimes / offences including Road Traffic offences, Assault, Vandalism, Theft, Drugs, Anti-Social Behaviour and Domestic incidents.

**Forthcoming Operations:**

There is a planned Acquisitive Crime operation for Monday 4 to Wednesday 6 September 2017.

I would ask again for the public's assistance with this. If you see or hear anything suspicious please report it at the time you see it on 101.

Our team is committed to keeping the community safe, preventing and detecting crime. If any suspicious activity is seen, please report this to us, either as an emergency on 999 or to the Service Centre on 101. Quick and effective reporting allows our team to react accordingly and maximise the opportunity to apprehend offenders.

Using this process negates the possibility of the report being missed and also ensures that the callers detail, addresses and telephone numbers are noted for our awareness and response.
